Sub: Haj 1443 (H) – 2022 (C.E.). Remittance of Haj Amount.

As per para 9.2 of the Guidelines for Haj 1443 (H) – 2022 (C.E.), all provisionally selected pilgrims are required to deposit Advance Haj Amount @ Rs.81,000/-each.

2. Payments can be made either,
 - a. Online at i.e. <https://hajcommittee.gov.in> ; or
 - b. In Haj Committee of India account maintained with SBI or account maintained with UBI through any branch of SBI/UBI having core Banking System by using unique Bank Reference Number in the Specified Pay-in-slip on website.
 - c. By cheque of any branch of SBI/UBI in the respective Bank.
3. Final instalment will be decided after finalization of tender for Airfare amount & Saudi expenses received by CGI, Jeddah will be intimated later. The details of expenditure for Haj-2022 for respective Embarkation and Accommodation will be displayed on website i.e. <https://hajcommittee.gov.in>.
4. The unique **Bank Reference Number** provided to each Cover must be mentioned in the Remittance Receipt.
5. After depositing the Advance amount the Provisionally Selected pilgrims shall submit a copy of the pay-in-slip, along with Medical Screening and Fitness Certificate (as per format available in the website i.e. <https://hajcommittee.gov.in>) and original International Machine readable passport to the concerned State Haj Committee on or before 06th May, 2022.

It is hereby notified that the pilgrims must adhere to the last date for remittance of Advance Haj Amount and submission of documents in the concerned State Haj Committees as prescribed by Haj Committee of India, failing which their Haj seat will be cancelled.
